**Rules for Entry:**

- Judging is based on creativity, design and execution. All entries must be the original work of the artist, without assistance from instructors, except for supervised student work. **No copies or reproductions are eligible for entry.** We cannot protect you from copyright infringement. The DRCA has the right to reject artwork if we feel it violates copyright laws and/or if it is too provocative by either profane or sexually explicit.
- Category of artwork, eligibility or display of submission may be changed at the discretion of the hanging committee.
- Two-dimensional art must be dry and **securely framed for wire hanging only.**
- Artwork must have been completed within the past two years and never before exhibited in the Judged Show.
- Entries may not be removed before Saturday **June 1** without permission of the Firehouse staff.
- *The Del Rio Council for the Arts will receive 30% commission on all works sold during the show.*
- The Firehouse is not responsible for theft or damage to individually owned artwork displayed. It is advisable that personal insurance coverage for artwork be obtained.
